In 1995 author Betsy Hart wrote, "The Violence Against Women Act will do nothing to protect women from crime. It will perpetuate false information, waste money, and urge vulnerable women to mistrust all men."

Thirteen years later, that prediction has turned out to be right on target. Worse, the Violence Against Women Act, which now costs the federal government \$1 billion a year, has spawned an industry that undermines Constitutional protections, thwarts welfare reform, weakens military readiness, fosters immigration fraud, and is harmful to families.

This conference will probe how to rein in a federal law that increasingly encroaches on the personal lives of millions of Americans.
